## **About B&R Beurs**

B&R Beurs is the student investment society of Erasmus University Rotterdam. Our mission is to help members master the art of investing. We shape this purpose by different means such as the B&R Beurs academies, during which new members are taught about the financial sector by veteran members and guest lecturers. This knowledge is broadened by a large number of readings, workshops, classes and inhouse days. Besides this, the theory about investing is put into practice during our investment competition.

#### Members

B&R Beurs has a broad range of members. From near professional investors to people who have a basic interest in investing. We have a very mixed society with both Dutch and international members, counting more than 25 nationalities! Most of our members study Economics, Econometrics, Finance, or Business Administration. However, many other studies like Law and Mathematics are also represented. We have a wide variety of activities where most members enjoy sharing ideas and experiences with one another. If you have an interest in investing or the financial world in general, look no further! At B&R Beurs we have a very broad range of social, career and educational activities with our investment groups tied to an investment competition at its core.

Investment Competition
The core activity of B&R Beurs is investing. Every year, the society organises the investment competition. Investments are made with real money in real stocks, options and bonds for example. Investing takes place on a group level, with investment groups ranging from twelve to thirty five members. Investment groups usually meet once every two weeks, but there are also groups that meet every week. Throughout the year, you will jointly invest your capital, consisting of participations rang-

ing from €200 to 400 per member.

#### Education

In September, the new B&R educational program will start. The academies start with the basic principles of investing, aimed at novice members. The B&R academies are the ultimate method for learning all facets of investing. The academy course consists of multiple tracks. You can read more about this on the pages 'Education & Career'. 
**Formation Period**

## **Education & Career**

An important part of B&R Beurs is the provision of educational activities and academies as well as career events. These help you in expanding your financial knowledge. This section explains how B&R Beurs offers you these things during the upcoming academic year.

#### **Academies**

B&R Beurs hosts academies during the year for its members. This is the best place to expand your financial knowledge. On Thursdays, lectures are prepared by our Academy Committee to help you understand a variety of topics in investing. This committee consists of well-experienced members of B&R Beurs who also present these academies. Furthermore, the last academy of each track is given by a partner in a so called 'professional academy'. In this way, you get to learn the theory behind several investing topics, but also how this knowledge is applied in practice. You as a member are very welcome to attend these lectures, as we want to provide the opportunity to expand your financial knowledge. Also B&R Beurs aims to keep these academies interesting for everyone regardless of your education, experience level or prior knowledge about Finance. The academies are organized by dividing the theory into six essential tracks.

#### § Fundamental Analysis

Learn about the core foundations of a business to decide whether this would be a good investment proposition. You will analyse the underlying value of a security by applying several methods to conclude whether securities are undervalued or overvalued.

#### § Macro Investing

Learn during this track how macro-economic factors like interest rates and the business cycle affect financial markets. Moreover, it is discussed how large hedge funds have used this theory to create some successful trade and investment ideas.

#### § Portfolio Management

Learn to build a portfolio of individual securities. The concept of minimizing your risk is discussed while we also try to understand the drivers of your portfolio's return.

#### § Alternative Investments

In this track, you will learn more about investments outside of the financial markets, in which you can also put your money to work. In particular, Private Equity, Venture Capital and hedge funds are discussed. But also we learn about the concept of investing for start-ups and real estate.



#### § Derivatives

Learn more about the function of derivatives, futures and turbos. The usefulness of incorporating derivatives into your investment portfolio is discussed during these academies.

#### § ESG Investing

A relatively new chapter that gets increasingly more important in the world of investing is ESG. It stands for Environmental, Social and Governmental. More and more companies are focusing on more sustainable investments. This motivates all companies even more to become more sustainable and focus more on, for example reducing their footprint.

In addition to these academies, partners host quest lectures all year round. These are great opportunities for you to get some insights in how theories are applied in practice. Over the years, we have had guest lectures from Aegon, APG, Flow Traders, Optiver, Transtrend, STX Group and many more.

#### Investors Exam

After attending the academies, B&R Beurs offers the opportunity to take the Investor Exam. This exam covers all material that is covered during our academies. Subscribe for this exam and display you are seriousand ambitious about investing. Note that this exam has been prepared in collaboration with CAIA, a highly respected and recognized educator in the financial industry!

#### **Workshops**

Throughout the year, B&R Beurs also organizes other educational activities to improve your financial knowledge. The Trading Days is a successful cycle of events that teaches you more about the way firms trade, where the workshops vary from algorithmic trading to commodity trading. The Bloomberg Cycle also offered our members the opportunity to learn how the Bloomberg Terminal helps you to find the appropriate information of a country, sales of a specific firm or even all ins and outs of the Dutch royal family! This terminal is very popular in Finance and used by the largest firms in the financial industry. Then, several masterclasses and cases are organized throughout the year. Here, partners teach you about relevant topics or problems that they encounter nowadays.





#### Career Support

Next to our educational events, B&R Beurs also provides its members with career services to help you kickstart your career in Finance. B&R Beurs organises a range of careercycles: Career Days. The Career Committee is there to help you with different matters. They can assist you in for example professionalizing your CV or writing a convincing motivation letter. #### Investment competition

After you apply all the knowledge that you gained during our educational activities in your investment proposals, it is time to compete with all other investment groups. B&R Beurs hosts The Flow Traders Investment Competition, which is the core activity of B&R Beurs. Members of the society cooperate in groups and invest real money. Each week, return and risk ratios are calculated and reported. Volatility is calculated as the standard deviation of the weekly returns. The investment group with the highest risk adjusted return at the end of the academic year wins the trophy.



## Investment Week & Symposium

Whether you already know exactly where you would like to work after your studies or you are still discovering what line of business you find interesting; the Investment Week & Symposium is the best event to get in contact with businesses from around the world!

The largest and most prestigious event of B&R Beurs is the yearly returning Investment Week & Symposium (IW&S). #### **Beer Cantus**



## Investing 101

Welcome to an important chapter: an introduction to investing. The practice of investing plays a central role in the financial sector and is getting increasingly popular on a personal level. Many people are drawn to it due to stories of wealth. The famous success stories of Warren Buffet and Benjamin Graham have attracted many investors to a quest of fortune: you are going to invest and become rich. So, full of excitement, you open your brokerage account and buy your favourite companies. The adrenaline starts rushing through your veins. Then it happens: nothing. You start feeling frustrated as your beloved companies barely move. This is the first lesson: investing takes time and patience and it should not be rushed. Your 'long' positions will probably grow with only 3% a year, not per week, not per day. Investing on its own won't make you rich nor will it happen overnight.

So, how can we work towards a return of more than 3% a year? Well, the keyword is knowledge. Investments should be made with sufficient knowledge of the securities (i.e. the products that are traded such as stocks or bonds) that you can buy and their underlying value. The general principle of investing concerns the relationship between the price and the underlying value. The price is the amount of money for which you purchase the product. The value is what the security is actually worth. The key idea here is that the price will move towards the actual value over time. How do you determine the value, you might wonder. This is what we call the fundamental analysis.

The fundamental analysis helps you to understand the company and work towards finding the underlying value. You want to determine if the company is overvalued (the price is higher than the value) or undervalued (the value is higher than the price). A key concern here is the business model.

How does the company make money? Is Mc-Donald's selling hamburgers or investing in real estate? As you are interested in finding the underlying value to predict where the price will go, it is important to take the future earnings and cash-flow into account.

These numbers can serve as indicators of good or bad companies. The basic idea is that everything the company will ever sell will eventually turn into ice-cold cash. Cash can be used to make investments or to distribute to the shareholders through dividends. Cash and future prospects of cash-flow lie at the basis of fundamental analysis. The value of a company is the present value of its cash-flow. Your job is to find the future cash-flow to reach the holy grail of investing: the future value of the company. You divide this number by the amount of shares and, voilà, you have found the value of an individual stock. Compare this to the current price and you conclude whether the company is under- or overvalued. If the security is undervalued, you want to go 'long' by buying the stock.



On the other hand, if the stock is overvalued, you can go 'short'. Shorting means that you lend the stock from an investor, sell it now, and buy it back later to return it to the investor. Do the maths and you will now see that the decrease (increase) in price is your profit (loss).

If you keep an eye on stock prices for a while, you will notice that their volatility could be very high. In other words, the extent to which the price of the stock moves up and down can be very large, even without any new significant news that could affect a company's future cash flow. In these situations, you may wonder what the best moment would be to take or exit a long or short position such that you generate even more profit. This so-called technical analysis of a potential investment is about reading and predicting stock prices based on historical data. An often-occurring pattern is an increase before a decline and a decline before an increase. These patterns are called resistances and supports, respectively.

Have you ever wondered why the logo of B&R Beurs shows a bull and a bear? Investors label the markets 'bullish' or 'bearish'. Periods of 'bull' markets show economic growth. In times of 'bear' markets, the market goes down. People tend to trade more on emotions in bear markets, which causes these markets to be more volatile. These situations could create more opportunities for rational investors like vou. as vou invest in the underlying value of securities. Investors can choose between risky and more conservative investments. A great example of this difference is the investments in stocks and bonds, where investors can enjoy the ride of volatile markets (stocks) or manage stable investments that are less affected by fluctuations (bonds).

Investing for many investors means maximising returns while minimising risks. Professional investors usually create portfolios in which they can aim for this objective. By investing in a portfolio of securities, you take diversification into account.



You buy and sell shares of companies that do not correlate much to each other – this means that the prices are less likely to behave similarly. In this way, your entire investment is less sensitive to failures of one security.

A clear example of investing in a diversified way is buying a so-called Exchange Traded Fund (ETF). This index tracks a portfolio of stocks. An even more extensive form of creating your diversified portfolio is also determining the proportion of every single security in your basket that you trade.

All of this, in a nutshell, the basics of investing. You are advised to read annual reports and analyses and explore some graphs. It all starts with a fundamental analysis, after which you determine your moment to enter or exit using a technical analysis. If you follow these steps, you should be able to realise an average return of 6% on an annual basis.

During the academies at B&R Beurs, we elaborate on these theories and go into more depth on how you can improve your return and create good portfolios. Wellknown books about investing that are recommended for you to read are 'A Random Walk around Wall Street' and 'The Intelligent Investor'. 


